

# TERMS OF SALES

The association can offer virtual exhibitions and sales on artisanal, industrial, artistic products and innovative products made by French women business leaders.

By ordering on the website "www.LABEL F.C.E.F. - FRANCE et MONDE.com", and by checking the "register" box, which you click on when ordering, you confirm your acceptance of these general conditions of sale and agree to be linked to it.

By ordering on the website "www.LABEL F.C.E.F. - FRANCE et MONDE", and by checking the "register" box, which you click on when ordering, you waive, in full knowledge of the facts, your right to withdrawal in order not to wait for the end of the latter (14 days) before the start of the execution of the service, that is to say, wait until the 15th day to send the order...

The general conditions are also fully applicable to any order placed with ASSOCIATION LABEL F.C.E.F. – FRANCE and WORLD, thus any order will be exclusively governed by these general conditions, in full knowledge of the customer. The prices displayed on this Site are those in effect at the time of consultation by the Customer and at the time of their firm order.

They may be modified without notice, depending on the latest programming news or the latest changes beyond our control.

## A. GENERAL PROVISIONS:

Except with the express prior permission of the ASSOCIATION LABEL F.C.E.F. – FRANCE, it is forbidden to copy, download all or part of the Site or its contents. ASSOCIATION LABEL F.C.E.F. – FRANCE authorizes the creation of hypertext links to the Site.

## B. PROVISIONS APPLICABLE TO PAST ORDERS:

### Art.1: ACCEPTANCE OF THESE GENERAL CONDITIONS

The fact for a buyer to fill out and confirm the order form, and to transmit it to the ordering service, constitutes full and complete acceptance of these Terms and Conditions, which will be the only ones applicable to the contract thus concluded.

### Art.2: CONFIRMATION OF ORDER AND CONCLUSION OF CONTRACT

The Site contains at any time a commercial proposal for the sale of products, which is not legally considered as a permanent offer. The order is deemed valid unless denounced by the Association U.F.E. Sousse. After validation of the payment, in accordance with art.4.1 hereof, the order is deemed accepted by the U.F.E. Sousse. This confirmation, or if necessary the refusal to accept an order will be confirmed to the buyer no later than 7 working days after receipt of an order by one of the following means: phone call or email. ASSOCIATION LABEL F.C.E.F. – FRANCE further reserves the right not to record a payment and therefore not to confirm an order for any reason whatsoever, in particular due to a problem of shortage, a problem concerning the order received, or a foreseeable problem concerning the delivery of the products to be made.

## Art.3: GENERAL OBLIGATIONS OF THE PARTIES

### 3.1 Obligations of ASSOCIATION LABEL F.C.E.F. – FRANCE :

ASSOCIATION LABEL F.C.E.F. – FRANCE undertakes, in case of acceptance of an order, to have delivered to the buyer (the "Customer"), the products ordered by the latter (the "Products").

In this respect, the U.F.E. SOUSSE undertakes to deliver the products to the carrier of its choice, as soon as possible after the acceptance of an order.

### 3.2 Obligations of the Customer:

Customers undertakes to inform ASSOCIATION LABEL F.C.E.F. – FRANCE an address to which delivery can be made during business hours. The Customer agrees to pay the stipulated price for the delivery of ASSOCIATION LABEL F.C.E.F. – FRANCE.

## Art.4: SPECIFIC PROVISIONS

### 4.1 Price, invoice:

The overall price indicated in the order confirmation by Association LABEL F.C.E.F. – FRANCE and WORLD (known as the "Price") is the price excluding taxes (excl. VAT) + transport costs (France or Abroad) for sending the "products" (+ customs fees for export or import).

The Price is expressed in Euros.

Payment for the Products is made either by bank transfer, and at the time of ordering, after having collected the total payment, and at the end of the solvency period established by the banks, or by international postal money order, after having collected the species.

The order will be deemed firm and non-refundable, after the customer's payment action.

An invoice is issued, at the specific request of the Customer, which must indicate the address of sending the invoice.

#### **4.2 Transportation - Delivery - Delivery Times :**

The Products are delivered to the address indicated in the order and as soon as possible, by normal postal delivery, by mutual agreement with the customer.

#### **4.3 Reserves on delivery :**

Our products travel at the risk and peril of the Customer and the U.F.E. SOUSSE is released from any responsibility for any delay in delivery, or loss of mail or other transport risk.

In the event of damage occurring during the transport, the Customer must make with the carrier all reservations written on the delivery and by registered letter within three days of receipt. A copy of these reservations must be sent to the U.F.E. SOUSSE, accompanied by confirmation by the carrier of the reality of these reservations.

In no case, the U.F.E. SOUSSE can not be responsible for any deterioration of the Products.

#### **4.4 No Return - Limiting Refund / Replacement Cases :**

No return and refund of Products will be accepted or any product replacement.

If the above procedure has been followed, and if it is proved that the reserves are due to the fact that the package (s) and the Products are heavily damaged, the Transport Company will reimburse the customer at the cost of the declared value.

#### **4.5 Warranty – Limitation :**

The U.F.E. SOUSSE warrants that the Products have been the subject of all necessary care to ensure compliance with the description on the Site at the date of the order. The U.F.E. SOUSSE is released from any responsibility, on the specific and changing expectations of the customer.

#### **4.6 Liability - Limitation of liability :**

The Customer is solely responsible for the choice of Products.

### **C. APPLICABLE LAW - COMPETENT COURTS - RIGHT OF ACCESS TO FILES**

These General Conditions are governed exclusively by the laws in force.

The District or High Courts of Angoulême, Charente - FRANCE will have sole jurisdiction for any litigation or dispute concerning them.

The Customer has a right of access and rectification to information concerning him from Association LABEL F.C.E.F. – FRANCE and WORLD.
